The **Student** acknowledges this agreement is not in lieu of and does not negate the requirement to pay the non-refundable Field School deposit. This Agreement will become valid only after such deposit fee has been processed and cleared.

This Payment Plan Agreement eliminates the imposition of the Late Fee but does not change or alter the **ARC** Cancellation or Withdrawal policies.

Except as expressly set forth here, no other changes to the **ARC** Cancellation Policy and Participant Agreement are implied or intended. The Field Training Cancellation Policy, Participant Agreement and this agreement shall be read and construed as one agreement.

Except as expressly provided in this agreement, all the terms and provisions of the Cancellation Policy and Participant Agreement are and will remain in full force and effect.
